**Previous Minutes:** M/S/P Approve previous minutes.

<u>Financial Report:</u> M/S/P Approve current balance sheet and transactions #2959 thru #2977 including debit card transactions during the same time period. Reviewed the Fall Tournament Financial Report. M/S/P Approve the Fall Tournament Financial Report with knowledge of income still due from District 7 to finalize. There was much discussion concerning the decision made by the District 5 Board on district tournament finances for leagues spanning the two districts. M/S/P Approve the Executive Secretary sending a letter to District 5 indicating the desire to meet with their committee concerning this issue. # **WIAA Executive Board Report:**

Some of the issues that will be discussed are, modification of State track for religious purposes, 2<sup>nd</sup> reading on 1A boys soccer to spring, classification updates, State tournament sites for 2006-08, looking at 3A State basketball tournament formats (possibly different), evaluate 3-person mechanics. Jim also asked about how Rep Assembly should be done this spring. The consensus was that it needs to be kept the same.

CWAC – Talked about sub-district qualifier, passed out maps for spring events, district brackets for basketball, approved Ellensburg, Prosser, Selah, and Wapato as members of the league. At a next years league meeting they set up officers and looked at formats for each sport for next year,

Big 9 – Now a 14 team 4A/3A league starting next year. The majority of the meeting was about schedules for each sport next year and a Kennewick eligibility issue.
