Previous Minutes: M/S/P Approve previous minutes.

<u>Financial Report:</u> M/S/P Approve current balance sheet and transactions #4288 thru #4499 including debit card transactions during the same time period. M/S/P Approve the fall tournament financial report. Reviewed the winter sports tournament financial reports to date. After much discussion about the 1A basketball tournament financial report a motion failed to adjust one of the tournament personnel's compensation as requested by the site manager. The district director was instructed to send a letter to the site manager indicating the decision and to correct an error in the payment to the person in the amount of an additional \$25.00. Reviewed preliminary winter tournament share for 4A/3A 2A winter district tournament events hosted in district 6.

Correspondence:

Memo from district director indicating e-mail approval of cooperative track program this spring for Manson and Chelan. **M/S/P Approval of a request for a cooperative golf program this spring for Bridgeport and Brewster.** Copy of letter sent to Bridgeport High School concerning coach's comments in the local newspaper.

WIAA Executive Board Report:

Board approved the Cascade Christian request to count Sunday towards meeting the minimum pre-contest practice requirements as long as they only count 6 days during a given week. Approved increase in girls state wrestling entries. Approved moving the 1A softball championships to Spokane. Approved moving the 1A and 2A baseball championships to Spokane. Approved Sprague-Harrington moving from district 9 to district 7. Approved for this spring that a jamboree any sport may be held during the first 4 weeks.

Eligibility:

Three cases were heard this spring with one being denied. Only Three exchange students were reported for spring.

League Reports:

B – guests from White Swan requested to join league, geographic challenges meant a denial, Cascade Christian basketball & volleyball request to join league with no post season approved, Columbia Basin Alt. request to join league for boys basketball approved, discussion on need for communication between AD's & Coaches, request to the District Board concerning district 1A/B boys tennis be separate tournaments. M/S/P (7/6/1) Approve the splitting of 1A & B boys tennis with the B schools receiving the #3 seed and the 1A schools receiving the #1, #2, and #4 seeds to the State 1A/B Tennis Tournament.

1A – reviewed winter post-season reports, 1A regional reps attended a regional meeting for next year, Cashmere was voted into league for boys soccer, reviewed spring sub-varsity, scheduling during WASL, spring coaches meetings, request for combined baseball program for Chelan/Entiat failed, approved a cooperative track program for Manson/Chelan.

2A – Updated spring schedules, reports on winter tournaments, discussion of crowd control issues at winter events, in the process of making changes in some of the SOP's, discussion on ejections.

4A/3A –Did some work on schedules for next 2-year cycle, district formats for post-season for next year, names for the two division within the league at this time are Columbia & Cascade, administrators want a reconsideration of the name change back to Big Nine,

discussion about basketball district, whether to use neutral sites and to have 1 neutral official, approved 3 golfers to ride cart 1 permanent disability other 2 temporary disabilities.
