Bulletin #5 NCWAA Executive Board Meeting March 17, 2010 Apple Cup Cafe Chelan, WA

President Steve Chamberlin called the meeting to order at 9:10 am.

Additions to the Agenda: None.

Previous Minutes: M/S/P Approve previous minutes.

<u>Financial Report:</u> M/S/P Approve current balance sheet and transactions #5689 thru #5892 including debit card transactions during the same time period. The director shared information concerning additional fall income from District 5 for football, soccer and swimming/Diving events that occurred in their district. M/S/P Approve the winter tournament financial reports with the understanding that there will be a little more income received from radio stations.

The director shared a sheet that showed the basic financial structures for all of the WIAA districts. There was some discussion and clarification, but no action was desired from the group.

<u>Correspondence:</u> A memo indicating the approval by the board via e-mail for a request for a combined boy's soccer program for Manson High School and Mansfield High School. Also in the same memo the approval for a cooperative boy's golf program for Omak High School and Okanogan High School. **M/S/P Approve combined programs in baseball and softball for Manson High School and Mansfield High School.** Copies of letters sent to radio station billing them for broadcasting 1A, 2B and 1B district basketball games.

**WIAA Report:** Next meeting in a week. Topics to be discussed include, 32-man wrestling tournament, policy concerning the handling of 1<sup>st</sup> and 2<sup>nd</sup> round football and soccer games site selection, first reading of the budget which will include a substantial increase in L & I billings that will be passed on to the member schools next year.

### **League Reports:**

CW B – went over amendments, schedules for spring, reviewed basketball tournaments, finalized the master schedule for basketball next year, accepted 3 district 5 schools into the league, put together divisions for 2B portion of the league, discussed junior high issues, approved Manson and Mansfield combining in baseball and softball, 2B worked on spring for next year and major discussion about wrestling for next year.

CTL – talked about policy for changing games or contests dates or times, reviewed the basketball and wrestling schedules for next year, discussion about the tennis district tournament format with or without the inclusion of the B schools.

CWAC – discussion of playoff sites - weather to go back to neutral sites (basketball primarily), talked about wrestling officials costs, explored next year's spring schedules because schools are on spring break on 3 different weeks, this years spring sports number of teams, tried to work on double duals for wrestling but scrapped it, looked at some district formats for the future, most schools want to go back to full sub-varsity schedule. Voted to stop using Digital Sports because of problems with them.

Big 9 – reviewed winter tournaments, shared spring teams numbers, 3 self-reports of students on the basketball floor immediately after the game after game, self-report dealing with a coach recruiting.
