CWAC – Reviewed district regional basketball results and a discussion of bands at the events. Revisited track entries for district track meet, reviewed coaches vs. cancer basketball game, discussion of swimming and league alignment next year, discussion of bowling for next year.

Big 9 – a debate on schedules and swimming may have issues to work out for next year.
