### Reports/ Correspondence:

Director: BJ Kuntz-

- Discussion around Regional Wrestling Alignments. Loren shared the process that has taken place and the encouraging news that the Big 9 found success in the plan they offered for pairing at Regionals. Loren explained the math for the Big 9 / KingCo and how it mirrors the CTL situation. CTL was encouraged to reach out to the NEA to dscuss similar format. Brief conversation around girls wrestling and the fact that we will know after the numbers of participants come out. Chelan asked about how schools are having coaches work with female wrestlers in terms of traveling to female events and the need to have 2 adults travel.
- Discussion about the timing for Rep Assembly / Winter Coalition.
  - District Directors and WIAA Staff have a conference call on 11/20
  - November 28th District 6 Exec Board meeting we will discuss the details of the amendments.
  - Leagues should discuss in detail in December to allow schools to go back to their leadership if needed.
  - January leagues should give direction to their District 6 board members.
  - Mid January District Directors and WIAA staff will meet again to discuss concerns / benefits from around the state.
  - January 16th District 6 Board Meeting will give direction to our voting members
  - January 28th Winter Coalition
  - Schools are encouraged to send questions / concerns to BJ prior to her November 20th conference call so she can get answers.
- Reviewed Fall District Venues for District / State Events. A few adjustments were made. M/S/P updated Venues.
   Discussion also around insuring home sites for 1st round of state have bleachers, ability to charge, access to restrooms. locker rooms. etc.
- AD of the year was discussed Waiting for the 4A to select winner. Voting for District 6 AD of the year will occur after the November 28th meeting.
- Provided copy of insurance for both District Events and the D&O insurance for District 6. Additional discussion around insurance for leagues and where each league is currently standing on this issue.
- Update on BJ's meeting with Kent Andersen in September around Agreements between our districts with 2B.

**WIAA - Miles Caples-** Information around the 4 Washington schools that have requested to join Oregon beginning the 2019-20 school year. WIAA Staff is working on policy language regarding Air Quality. Baseball Championships for 3A-4A at GESA, Pasco. WIAA staff is going to secure general liability for leagues and a fee structure will be developed for leagues to reimburse the association.

**Eligibility - Rob Rainville:** AD's are encouraged to review the appeal process in case you have to instruct / support families going through an appeal. There is currently 1 case from District 6 going forward to WIAA as an appeal. Winter Eligibility Hearings are currently scheduled on Tuesday November 13th at Eastmont High School. Be sure you get information to Rob with plenty of time. Depending on the cases, meetings can be moved.
