**WIAA: Miles Caples-** Last Executive Board meeting was in November. A lot of discussion in reference to scheduling of Football and establishing scheduled that provide competitive games for both teams. There is a lot of work happening in Western Washington. Also discussion around private vs public / equity / poverty. Scheduling for gymnastics has had challenges due to locations / dates and adequate access to needed equipment. RPI - teams are not putting scores into MaxPreps which is causing challenges. A lot of discussion about the process to get scores reported, especially for the schools that prefer using WPA Network.
